The information provided will be used solely to manage participation in the giveaway and to notify the winner and process the prize.

2. Temporal and Geographical Scope

- Participation dates: the draw will begin on Monday, September 21, 2026, at 14:00 (CEST) and end on Monday, September 28, 2026, at 23:59 (CEST).
- Geographical scope: this giveaway is global (international) in scope.
- Age: individuals over 18 years of age may participate.

3. Prize

Three (3) Infinity Hyperthermal bundles will be raffled off, with one (1) bundle awarded to each of the three (3) winners. Each bundle includes:

- 1x Infinity N5 Hyperthermal Book (ES / ENG)
- 1x Spec-Ops Box [choice of faction (PanOceania, YuJing, Combined Army)]
- 1x exclusive Rumbler Spec-Ops miniature
